# Purpose of the policy

St Richard's Catholic College is committed to ensuring that the exams management and administration process is run effectively and efficiently and in compliance with the published JCQ regulations and Awarding Body requirements.

This exam policy will ensure that:

- all aspects of the Centre's exam process is documented, supporting the exams contingency plan, and other relevant exams-related policies, procedures and plans are signposted to
- the workforce is well informed and supported
- all centre staff involved in the exams process clearly understand their roles and responsibilities
- all exams and assessments are conducted according to JCQ and Awarding Body regulations, guidance and instructions, thus maintaining the integrity and security of the exam/assessment system at all times
- exam candidates understand the exams process and what is expected of them

This policy is reviewed annually to ensure ways of working in the Centre are accurately reflected and that exams and assessments are conducted to current JCQ (and Awarding Body) regulations, instructions and guidance.

This policy will be communicated to all relevant centre staff, who will be signposted to the Exams Policy and asked to familiarise themselves with their relevant roles and responsibilities.

Candidates are briefed at regular intervals during the examination cycle, through signposting to all relevant JCQ documents, assemblies and newsletters. Pupils, Parents and Carers are also issued an Examinations Information booklet.

# Roles and responsibilities overview

**The head of centre** is the individual who is accountable to the awarding bodies for ensuring that the centre is always compliant with the published JCQ regulations and awarding body requirements to ensure the security and integrity of the examinations/assessments.

**The examinations officer** is the person appointed by the head of centre to act on behalf of, and be the main point of contact for, the centre in matters relating to the general administration of awarding body examinations and assessments.

The head of centre may not appoint themselves as the examinations officer. A head of centre and an examinations officer are two distinct and separate roles. (GR, section 2)

The head of centre and/or examinations officer may operate across more than one centre. In such cases the head of centre must ensure there is suitable support in place, so they can meet their obligations across all centres for which they are responsible. The head of centre must ensure that these arrangements are covered by their examination contingency plan. (GR, section 2)

# **Head of Centre responsibilities**

The head of centre is the individual who is accountable to the awarding bodies for ensuring that the centre is always compliant with the published JCQ regulations and awarding body requirements to ensure the security and integrity of the examinations/assessments. It is the responsibility of the head of centre to ensure that all staff comply with the instructions in this booklet. Failure to do so may constitute malpractice as defined in the JCQ publication Suspected Malpractice: Policies and Procedures, 1 September 2022 to 31 August 2023: https://www.jcq.org.uk/exams-office/malpractice (ICE Introduction)

### **Head of Centre**

- Understands the contents, refers to and directs relevant centre staff to annually updated JCQ publications including:
  - General Regulations for Approved Centres (GR)
  - Instructions for Conducting Examinations (ICE)
  - Access Arrangements and Reasonable Adjustments (AA)
  - Suspected Malpractice Policies and Procedures (SM)
  - Instructions for conducting non-examination assessments (NEA) (and the instructions for conducting coursework)
  - A guide to the special consideration process (SC)
- Ensures the centre has appropriate accommodation to support the size of the cohorts being taught including appropriate accommodation for candidates requiring access arrangements and/or practical assessments
- Where/if using a third party to deliver any part of a qualification (including its assessments) at the centre:
  - o maintains oversight of, and responsibility for, the delivery of the qualification in accordance with JCQ regulations and awarding body requirements
  - has in place a written agreement with the third party to ensure there is a shared understanding of the arrangement and will manage the risk of failure by the third party to deliver the expected service
  - ensures that a copy of the written agreement is available for inspection if requested by the awarding body
- Ensures that relevant members of staff respond promptly to actions raised by the JCQ Centre Inspection Service, understanding that failure to do so could result in the same penalties as listed in the previous bullet point
- Ensures that the centre promptly reports any incidents to the relevant awarding body/bodies which might compromise any aspect of assessment delivery such as a cyberattack
- Ensures other relevant centre staff where they may be involved in the receipt and dispatch
  of confidential exam materials are briefed on the requirements for maintaining the integrity
  and confidentiality of the exam materials
- Ensures members of centre staff do not forward emails and letters from awarding body or JCQ personnel without prior consent to third parties or upload such correspondence onto social media sites and applications
- Ensures members of centre staff do not advise parents/candidates to contact awarding bodies/JCQ directly nor provide them with addresses/email addresses of awarding body examining/assessment personnel or JCQ personnel

## Recruitment, selection and training of staff

- Retains a workforce of an appropriate size and competence, including sufficient managerial
  and other resource, to undertake the delivery of the qualification as required by an Awarding
  Body. This includes taking reasonable steps to ensure occupational competence where this
  is required for the assessment of specific qualifications
- Provides fully qualified teachers to mark non-examination assessments, and/or fully qualified assessors for the verification of centre-assessed components
- Enables the relevant senior leader(s), the Examinations Officer (Exams Officer) and the ALS lead/SENCo to receive appropriate training and support in order to facilitate the effective delivery of examinations and assessments within the centre, and ensure compliance with the published JCQ regulations
- Appoints an ALS lead/SENCo who will determine appropriate arrangements for candidates with learning difficulties and disabilities
- Ensures that the ALS lead/SENCo has sufficient time to both manage the access arrangements process within the centre and familiarise him/herself with the JCQ publication Access Arrangements and Reasonable Adjustments

 Ensures that the examinations officer is line managed and actively supported by a member of the senior leadership team who has a good working knowledge of the examination system

# **Internal governance arrangements**

 Has in place a written escalation process should the Head of Centre, or a member of The Leadership & Management Team with oversight of examination administration, be absent. In the event of such absence responsibility will be escalated to one of the five additional members of the Leadership & Management Team in the following order:

#### **Escalation Process**

- Has in place a member of the The Leadership & Management Team who will provide support
  and guidance to the Examinations Officer and ensure that the integrity and security of
  examinations and assessments is maintained throughout an examination series
- Ensures centre staff undertake key tasks within the exams process and meet internal deadlines set by the Exams Officer
- Makes sure that a teacher, a tutor or a senior member of centre staff who teaches the subject being examined, is not an invigilator during an examination

## **Delivery of qualifications**

- Delivers qualifications, as required by the Awarding Body, in accordance with relevant equality legislation. This includes but is not limited to ensuring that qualifications are made available to all candidates capable of undertaking them and seeking reasonable adjustments for disabled candidates
- Enables candidates to receive sufficient and up to date laboratory experience, or relevant training where required by the subject concerned

# **Public liability**

 Complies with local health and safety rules which are in place and that the centre is adequately covered for public liability claims

# **Security of assessment materials**

- Takes all reasonable steps to maintain the integrity of the examinations/assessments, including the security of all assessment materials, by ensuring:
  - o the location of the centre's secure storage facility in a secure room which must only be used for the purpose of administering secure examination materials
  - o the secure room only contains exam-related material
  - o there are between two and six keyholders only, each of whom must fully understand their responsibilities as a key holder to the secure storage facility
  - access to the secure room and secure storage facility is restricted to the authorised two to six keyholders and staff-approved by the head of centre are accompanied by a keyholder at all times
  - appropriate arrangements are in place to ensure that confidential examination materials are only handed over to authorised members of centre staff
  - o appropriate arrangements are in place for handling secure electronic materials
  - the relevant awarding body is immediately informed if the security of question papers or confidential supporting instructions is put at risk
  - that when it is permitted to remove question paper packets from secure storage, and to avoid potential breaches of security, arrangements are in place to carefully check and record that the correct question paper packets are opened

(If it is ever subsequently identified following this check that the wrong question paper packet has been opened, it will be resealed and the incident reported to the relevant awarding body's Malpractice Investigation Team immediately)

- Makes arrangements to receive, check and store question papers and examination material safely and securely at all times and for as long as required in accordance with the current JCQ publication *Instructions for conducting examinations*
- Makes arrangements to receive and issue material received from the awarding bodies to staff and candidates, and notify them of any advice and instructions relevant to the examinations and assessments
- Allows candidates access to relevant pre-release materials on, or as soon as possible after, the date specified by the awarding bodies

# Malpractice

- Through taking an ethical approach and working proactively to avoid malpractice among students and staff takes all reasonable steps to prevent the occurrence of any malpractice/maladministration before, during and after assessments have taken place
- Ensures any person involved in administering, teaching or completing
  examinations/assessments is advised that where malpractice is suspected, or alleged,
  personal data about them will be provided to the awarding body (or bodies) whose
  examinations/assessments are involved. Personal data about them may also be shared with
  other awarding bodies, the qualifications regulator or professional bodies in accordance
  with the JCQ publication Suspected Malpractice Policies and Procedures
- Ensures irregularities are investigated and informs the awarding bodies immediately of any alleged, suspected or actual incidents of malpractice or maladministration, involving a candidate or a member of staff, by completing the appropriate documentation
- As required by an awarding body, ensures evidence of any instances of alleged or suspected malpractice (which includes maladministration) is gathered in accordance with the JCQ publication Suspected Malpractice - Policies and Procedures and provides such information and advice as the awarding body may reasonably require

# Policies/procedures

 Ensures risks to the exam process are assessed and appropriate risk management processes/contingency plans are in place (that allow the senior leadership team to act immediately in the event of an emergency or staff absence)

# **Exam Contingency Plan**

A copy of the Exam Contingency Plan is kept in the Exams Office. An electronic copy is available from the Exams Officer.

# **Lockdown Policy (Exams)**

Ensures the centre has a Lockdown Policy in place. A copy of the Exam Contingency Plan is kept in the Exams Office. An electronic copy is available from the Exams Officer.

# **Internal Appeals Procedures**

Ensures required internal appeals procedures are in place and drawn to the attention of candidates and (where relevant) their parents/carers. St Richard's Catholic College's Internal Appeals Policy can be found on the school website.

# **Equalities Policy**

Ensures the Centre's equalities policy demonstrating the Centre's compliance with relevant legislation is in place and details the processes followed in respect of identifying the need for, requesting and implementing access arrangements. The Equality Policy for Exams can be found on the school website.

## **Complaints and Appeals Procedure (Exams)**

Ensures a Complaints and Appeals Procedure covering general complaints regarding the Centre's delivery or administration of a qualification is in place and drawn to the attention of candidates and their parents/carers. The Complaints and Appeals Procedure can be found on the school website.

# **Child Protection/Safeguarding Policy**

Ensures the centre has a Child Protection/Safeguarding Policy in place, including Disclosure and Barring Service (DBS) clearance, which satisfies current legislative requirements. The Child Protection/Safeguarding Policy can be found on the school website.

Ensures the centre has a Data Protection Policy in place that complies with General Data Protection Regulation and Data Protection Act 2018 regulations. The Data Protection Policy can be found on the school website.

# Whistleblowing Policy (Exams)

Ensures the centre has a Whistleblowing Policy (Exams) in place. The Whistleblowing Policy (Exams) can be found on the school website.

## **Access Arrangements Policy**

Ensures the centre has documented processes in place relating to access arrangements and reasonable adjustments. The Access Arrangements and Reasonable Adjustments policy can be found on the school website.

#### **Conflicts of interest**

- Ensures the relevant awarding bodies are informed before the published deadline for entries for each examination series of any potential conflict of interest where:
  - a member of centre staff is taking a qualification at the centre which includes internally assessed components/units (noting that being entered by the centre must be as a last resort where unable to find an alternative centre)
  - a candidate is being taught and prepared for a qualification which includes internally assessed components/units by a member of centre staff with a close relationship to the candidate
- Maintains clear records that confirm the measures taken/protocols in place to mitigate any
  potential risk to the integrity of the qualifications affected by the above, and where:
  - a member of exams office staff has a close relationship to a candidate being entered for exams and assessments at the centre or at another centre
  - a member of centre staff is taking a qualification at the centre which does not include internally assessed components/units (noting that being entered by the centre must be as a last resort where unable to find an alternative centre)
  - o a member of centre staff is taking a qualification at another centre

## **National Centre Number Register**

- Provides contact details and an address to which all correspondence in connection with the administration of examinations and assessments can be directed which must be the registered address of the centre
- Ensures the National Centre Number Register annual update is responded to by the end of October
- Takes responsibility for confirming, on an annual basis, that they are both aware of and
  adhering to the latest version of the JCQ's regulations. This confirmation is managed as part
  of the National Centre Number Register (NCNR) annual update

- Understands that this responsibility cannot be delegated to a member of the senior leadership team or the examinations officer, and acknowledges that failure to respond to the NCNR annual update, and/or the head of centre's declaration, will result in:
  - o the centre status being suspended
  - o the centre not being able to submit examination entries
  - o the centre not receiving or being able to access question papers and ultimately, awarding bodies could withdraw their approval of the centre

# **Centre inspections**

- Co-operates with the JCQ Centre Inspection Service, an Awarding Body or a regulatory authority when subject to an inspection, an investigation or an unannounced visit, and takes all reasonable steps to comply with all requests for information or documentation made by an Awarding Body or regulatory authority as soon as is practical
- Allows all venues used for examinations and assessments, paperwork and secure storage facilities to be open to inspection
- Understands the JCQ Centre Inspector will identify him/herself with a photo ID card and must be accompanied throughout his/her tour of the premises, including inspection of the Centre's secure storage facility

- Understands the contents of annually updated ICQ publications including:
  - General Regulations for Approved Centres
  - Instructions for conducting examinations
  - Suspected Malpractice Policies and Procedures
  - Post-Results Services (PRS)
  - A guide to the special consideration process
- Completes/submits the National Centre Number Register annual update (administered on behalf of the JCQ member awarding bodies by OCR https://ocr.org.uk/administration/ncnannual-update/) by the end of October each year
  - Confirms the details or informs the awarding bodies of any changes to the centre's contact details through the National Centre Number Register
  - Informs the National Centre Number Register Team immediately (e-mail address ncn@ocr.org.uk) if any changes occur after the National Centre Number Register annual update has taken place
  - (Where it may be applicable) Informs the National Centre Number Register Team no later than 6 weeks prior to moving to a new address or a re-location of the secure storage facility
  - o Informs the National Centre Number Register Team immediately of any other changes in circumstances that could affect the centre's status
- Is familiar with the contents of annually updated information from awarding bodies on administrative procedures, key tasks, key dates and deadlines
- Ensures key tasks are undertaken and key dates and deadlines met
- Recruits, trains and deploys a team of internal/external invigilators; appoints lead invigilators, as required and keeps a record of the content of training provided to invigilators for the required period
- Works with the ALS lead/SENCo to ensure invigilators supervising access arrangement candidates and those acting as a facilitator supporting access arrangement candidates fully understand the respective role and what is and what is not permissible in the exam room
- Supports the head of centre in ensuring that awarding bodies are informed (where
  required) of any conflict of interest declared by members of centre staff and in maintaining
  records that confirm the measures taken/protocols in place to mitigate any potential risk to
  the integrity of the qualifications affected before the published deadline for entries for each
  examination series
- Briefs other relevant centre staff where they may be involved in the receipt and dispatch of confidential exam materials on the requirements for maintaining the integrity and confidentiality of the exam materials

## Leadership & Management Team

- Are familiar with the contents, refer to and direct relevant centre staff to annually updated
   JCQ publications including:
  - General Regulations for Approved Centres
  - Instructions for Conducting Examinations
  - Access Arrangements and Reasonable Adjustments
  - Suspected Malpractice Policies and Procedures
  - Instructions for conducting non-examination assessments (and the instructions for conducting coursework)
  - A guide to the special consideration process
- Ensure teaching staff undertake key tasks, as detailed in this policy, within the exams process (exam cycle) and meet internal deadlines set by the EO and ALS lead/SENCo
- Ensure teaching staff keep themselves updated with awarding body subject and teacherspecific information to confirm effective delivery of qualifications
- Ensure teaching staff attend relevant awarding body training and update events

# Additional Learning Support (ALS) lead/Special educational needs co-ordinator (SENCo)

- Understands the contents, refers to and directs relevant centre staff to annually updated JCQ publications including:
  - Access Arrangements and Reasonable Adjustments
- Leads on the Access Arrangements and Reasonable Adjustments process (referred to in this policy as 'Access Arrangements')
- If not the qualified access arrangements assessor, works with the person appointed, on all matters relating to assessing candidates and ensures the correct procedures are followed
- Presents when requested by a JCQ Centre Inspector, evidence of the assessor's qualification

## **Teaching staff**

- Undertake key tasks, as detailed in this policy, within the exams process and meet internal deadlines set by the Exams Officer and ALS lead/SENCo
- Keep updated with Awarding Body subject and teacher-specific information to confirm effective delivery of qualifications
- Attend relevant Awarding Body training and update events

# **Invigilators**

- Attend/undertake training (on the current regulations), annual update, briefing and review sessions as required
- Provide information as requested on their availability to invigilate
- Sign a confidentiality and security agreement and confirm whether they have any current maladministration/malpractice sanctions applied to them

# **Reception staff**

 Support the Exams Officer in the receipt and dispatch of confidential exam materials and follow the requirements for maintaining the integrity and confidentiality of the exam materials

## Site staff

• Support the Exams Officer in relevant matters relating to exam rooms and resources

# **Candidates**

Where applicable in this policy, the term 'candidates' refers to candidates and/or their parents/carers.

#### The exam cycle

The exams management and administration process that needs to be undertaken for each **exam** series is often referred to as the **exam cycle** and relevant tasks required within this grouped into the following stages:

planning

- entries
- pre-exams
- exam time
- results and post-results

This policy identifies roles and responsibilities of centre staff within this cycle.

## Planning: roles and responsibilities

# **Information sharing**

## **Head of Centre**

Directs relevant centre staff to annually updated JCQ publications including GR, ICE, AA, SM,
 NEA (and the instructions for conducting coursework) and SC

# **Exams Officer**

- Signposts relevant centre staff to JCQ publications and Awarding Body documentation relating to the exams process that have been updated
- Signposts relevant centre staff to JCQ information that should be provided to candidates
- As the centre administrator, approves relevant access rights for centre staff to access
   Awarding Body secure extranet sites

# Information gathering

#### **Exams Officer**

- Undertakes an annual information gathering exercise in preparation for each new academic year to ensure data about all qualifications being delivered is up to date and correct
- Collates all information gathered into one central point of reference
- Researches Awarding Body guidance to identify administrative processes, key tasks, key dates and deadlines for all relevant qualifications
- Produces an annual exams plan of key tasks and key dates to ensure all external deadlines can be effectively met; informs key centre staff of internal deadlines
- Collects information on internal exams to enable preparation for and conduct of Year 11 and Year 10 Mock Exams

# Leadership & Management Team

- Respond (or ensure teaching staff respond) to requests from the Exams Officer on information gathering
- Meet the internal deadline for the return of information
- Inform the Exams Officer of any changes to information in a timely manner minimising the risk of late or other penalty fees being incurred by an Awarding Body
- Note the internal deadlines in the annual exams plan and directs teaching staff to meet these

# **Access arrangements**

## **Head of Centre**

- Ensures there is appropriate accommodation for candidates requiring access arrangements in the centre for all examinations and assessments
- Ensures a written process is in place to not only check the qualification(s) of the appointed assessor(s) but that the correct procedures are followed as per Chapter 7 of the JCQ publication Access Arrangements and Reasonable Adjustments
- Ensures the ALS lead/SENCo is fully supported in effectively implementing access arrangements and reasonable adjustments once approved

#### ALS lead/SENCo

- Assesses candidates (or works with the appropriately qualified assessor as appointed by the head of centre) to identify access arrangements/reasonable adjustments requirements
- Gathers evidence to support the need for access arrangements for a candidate
- Liaises with teaching staff to gather evidence of normal way of working of an affected candidate
- Determines candidate eligibility for arrangements or adjustments that are centre-delegated
- Gathers signed Personal data consent forms from candidates where required and ensures Data protection confirmation(s) by the examinations officer or SENCo are completed
- Applies for approval through Access arrangements online (AAO) via the Centre Admin Portal (CAP), where required or through the Awarding Body where qualifications sit outside the scope of AAO
- Keeps a file for each candidate for JCQ inspection purposes containing all the required documentation (if documentation is stored electronically, an e-folder must be created for each individual candidate. The candidate's e-folder must hold each of the required documents for inspection.)
- Employs good practice in relation to the Equality Act 2010
- Liaises with the Exams Officer regarding exam time arrangements for access arrangement candidates
- Ensures staff appointed to facilitate access arrangements for candidates are appropriately trained and understand the rules of the particular arrangement(s) and keeps a record of the content of training provided to facilitators for the required period
- Works with the Exams Officer to ensure invigilators and those acting as a facilitator fully understand the respective role and what is and what is not permissible in the exam room
- Liaises with the relevant member of the senior leadership team on the centre's policy on the use of word processors in examinations

# The criteria St Richard's Catholic College uses to award and allocate word processors for examinations

The 'normal way of working' for exam candidates, as directed by the Principle, is that candidates handwrite their exams. An exception to this is where a candidate may have an approved access arrangement in place, for example, the use of a scribe/speech recognition technology.

## **Awarding word processors**

There are also exceptions where a candidate may be **awarded** the use of a word processor in exams where he/she has a firmly established need, it reflects the candidate's normal way of working and by not being awarded a word processor would be at a substantial disadvantage to other candidates.

Exceptions might include where a candidate has, for example:

- a learning difficulty which has a substantial and long term adverse effect on their ability to write legibly
- a medical condition
- a physical disability
- a sensory impairment
- planning and organisational problems when writing by hand
- poor handwriting

# **Allocating word processors**

Appropriate exam-compliant word processors will be **allocated** by the ICT Services department in liaison with the ALS Lead/SENCo and the Exams Officer. In exceptional circumstances where the number of appropriate word processors may be insufficient for the cohort of candidates approved to use them in an exam session, the cohort will be split into two groups. One group will sit the exam earlier than or later than the Awarding Body's published start time. The security of the exam will be maintained at all times and candidates will be supervised in line with section 7 of ICE.

# **Separate Invigilation Policy**

 Ensures criteria for candidates granted separate invigilation within the centre is clear, meets JCQ regulations and best meets the needs of individual candidates and remaining candidates in main exam rooms

A decision where an exam candidate may be approved separate invigilation within the centre will be made by the ALS lead/SENCo.

The decision will be based on:

- whether the candidate has a substantial and long term impairment which has an adverse effect; and
- the candidate's normal way of working within the centre (AA 5.16)

- Any queries regarding a review of marking should be made directly to Subject Leaders and Teaching Staff, who will then advise as to whether the school will support the review. An answer will be given by the first week of the new school year.
- Procedures, deadlines and fees will be made available to pupils, parents and carers before the start of the exam season.
- If Subject Leaders and Teaching staff do not support a review of marking, an independent request should be made to the Exams Officer. Fee payment will be required before the request can be processed.
- As soon as the Exams Officer receives an outcome of a review of marking, the candidate will be notified by the means specified on the consent form. The Exams Officer can only release results to the candidate, unless prior written consent has been received.
- Should a candidate disagree with a centre decision not to support a review of results or an appeal please refer to the centre policy Internal Appeals Procedure. This can be found on the school website.

# Security of exam materials

  accompanied by a keyholder at all times. There must be between two and six keyholders
  only, each of whom must fully understand their responsibilities as a key holder to the secure
  storage facility
- Has a process in place to demonstrate the receipt, secure movement and secure storage of confidential exam materials within the centre
- Ensures a log is kept at the initial point of delivery recording confidential materials received
  and signed for by authorised staff within the centre and that appropriate arrangements are
  in place for confidential materials to be immediately transferred to the secure storage
  facility until they can be removed from the dispatch packaging and checked in the secure
  room before being returned to the secure storage facility in timetable order
- Carefully checks question paper packets when they are removed from the dispatch packing and keeps a log of the check

- Ensures the secure storage facility contains only current and live confidential material (ensuring that past examination question papers, internal tests and mock examinations are not kept in the centre's secure storage facility)
- Ensures that examination stationery, e.g. answer booklets and formula booklets are stored in the secure room (attempting to store this material in the secure storage facility, when sufficient space allows)
- Ensures the integrity and security of any electronic question paper is maintained during the downloading, printing and collating process (ensuring printing is carried out in an area that can be controlled to prevent unauthorised personnel accessing live assessment materials and ensuring only authorised members of centre staff have access to electronic question papers)

# Timetabling and rooming

The required declarations will be signed by all relevant parties and arrangements will only proceed if the Head of Centre and Exams Officer are confident that the integrity of the examinations process can be maintained.

#### Candidate late arrival

## **Exams Officer**

- Ensures that candidates who arrive very late for an exam are reported to the Awarding Body by submitting a report on candidate admitted very late to examination room using CAP to timescale
- Warns candidates that their script may not be accepted by the Awarding Body

## **Invigilators**

- Are informed of the policy/process for dealing with late/very late arrival candidates through training
- Ensure that relevant information is recorded on the exam room incident log

#### **Candidate Late Arrival Policy**

Candidates arriving late to an examination will be allowed to sit the examination, although the exam board may decide not to mark the paper. The Exams Officer will make a late arrival application via CAP, including all supporting evidence provided by the candidate, parent/carer.

# **Head of Centre**

# **Exam papers and materials**

#### **Exams Officer**

- Organises exam question papers and associated confidential resources in date order in the secure storage facility
- Attaches erratum notices received to relevant sealed exam question paper packets
- Collates attendance registers and examiner details in date order
- Regularly checks mail or email inbox for updates from Awarding Body's
- In order to avoid potential breaches of security, ensures care is taken to ensure the correct
  question paper packets are opened by ensuring a member of centre staff, additional to the
  person removing the papers from secure storage, e.g. an invigilator, checks the day, date,
  time, subject, unit/component and tier of entry, if appropriate, immediately before a question
  paper packet is opened
- Ensures this additional/second check is recorded
- Where allowed by the Awarding Body, only releases exam papers and materials to teaching departments for teaching and learning purposes after the published finishing time of the exam, or until any timetable clash candidates have completed the exam

## Exam rooms

#### **Head of Centre**

- Ensures that internal tests, mock exams, revision or coaching sessions are not conducted in a room 'designated' as an exam room
- Ensures that when a room is 'designated' as an exam room it is not used for any purpose other than conducting external exams
- Ensures only approved centre staff (who have not taught the subject being examined) are present in exam rooms to perform permitted tasks
- Ensures the Centre's policy relating to food and drink that may be allowed in exam rooms is clearly communicated to candidates
- Ensures the Centre's policy on candidates leaving the exam room temporarily is clearly communicated to candidates

# Food and Drink Policy (Exams)

Candidates may bring in a bottle of water, this should be clear, plastic and have all labels removed. Any other drinks or food, required for medical reasons, must have prior permission from the Head of Centre and Exams Officer

# **Leaving the Examination Room Policy**

Candidates are not permitted to leave the examination room before the official end time. Should a candidate need to leave the exam room to use the toilet or for medical reasons, they must raise their hand and wait for an invigilator, who will accompany them at all times.

- Ensures exam rooms are set up and conducted as required in the regulations
- Provides invigilators with appropriate resources to effectively conduct exams

- Briefs invigilators on exams to be conducted on a session by session basis (including the arrangements in place for any transferred candidates and access arrangement candidates)
- Ensures sole invigilators have an appropriate means of summoning assistance (if this is a
  mobile phone, instructs the invigilator that the mobile phone is only allowed to be used for
  this specific purpose and that it must be kept on silent mode)
- Ensures invigilators understand they must be vigilant and remain aware of incidents or emerging situations, looking out for malpractice or candidates who may be in distress, recording any incidents or issues on the exam room incident log
- Ensures invigilators understand how to deal with candidates who may need to leave the exam room temporarily and how this should be recorded on the exam room incident log
- Provides authorised exam materials which candidates are not expected to provide themselves
- Ensures invigilators and candidates are aware of the emergency evacuation procedure
- Ensures invigilators are aware of arrangements in place for a candidate with a disability who may need assistance if an exam room is evacuated

# Leadership & Management Team

- Ensure a documented emergency evacuation procedure for exam rooms is in place
- Ensure arrangements are in place for a candidate with a disability who may need assistance if an exam room is evacuated

# **Emergency Evacuation Policy**

A copy of The Emergency Evacuation Policy is available in all examinations rooms. Invigilators are briefed on/reminded of the procedure before the start of each exam series and internal exam periods.

An electronic copy of the policy is available from the Exams Officer or can be viewed on the Centre's website.

- Ensure exam rooms are available and set up as requested by the Exams Officer
- Ensure grounds or centre maintenance work does not disturb exam candidates in exam
- Ensure fire alarm testing does not take place during exam sessions

## **Invigilators**

 Conduct exams in every exam room according to JCQ Instructions for conducting examinations and/or Awarding Body requirements and as instructed by the centre in training/update and briefing sessions

#### **Candidates**

- Are required to follow the instructions given to them in exam rooms by authorised centre staff and invigilators
- Are required to remain in the exam room for the full duration of the exam

# **Irregularities**

# **Head of Centre**

Ensures (as required by an Awarding Body) any cases of alleged, suspected or actual
incidents of malpractice or maladministration before, during or after
examinations/assessments (by centre staff, candidates, invigilators) are investigated and
reported to the Awarding Body immediately, by completing the appropriate documentation

# **Managing Behaviour Policy**

Where a candidate is being disruptive, the invigilator must warn the candidate that he/she may be removed from the examination room. The candidate must also be warned that the Awarding Body will be informed and may decide to penalise them, which could include disqualification.

The invigilator must record what has happened...

(ICE 24)

# **Malpractice**

All reasonable steps are taken to prevent the occurrence of any malpractice (which includes maladministration) before, during and after examinations. Any alleged, suspected or actual incidents of malpractice are reported and investigated according to the requirements.

Staff are all signposted to JCQ Suspected Malpractice Policies and Procedures.

# Leadership & Management Team

- Ensure support is provided for the Exams Officer and invigilators when dealing with disruptive candidates in exam rooms
- Ensure that internal disciplinary procedures relating to candidate behaviour are instigated, when appropriate

#### **Exams Officer**

- Provides an exam room incident log in all exam rooms for recording any incidents or irregularities
- Actions any required follow-up and reports to Awarding Body's as soon as practically possible after the exam has taken place

# **Invigilators**

 Record any incidents or irregularities on the exam room incident log (for example, late/very late arrival, candidate or centre staff suspected malpractice, candidate illness or needing to leave the exam room temporarily, disruption or disturbance in the exam room, emergency evacuation)

# **Malpractice**

See Irregularities above.

## **Special consideration**

#### Leadership & Management Team

• Provide signed evidence to support eligible applications for special consideration

#### **Exams Officer**

- Processes eligible applications for special consideration to Awarding Body's
- Gathers evidence which may need to be provided by other staff in centre or candidates
- Submits requests to Awarding Body's to the external deadline

## **Special Consideration Policy**

The Special Consideration Policy can be found on the school website or by request from the Exam's Officer.

#### **Candidates**

Provide appropriate evidence to support special consideration applications, where required

#### **Unauthorised items**

## Arrangements for unauthorised items taken into the exam room

Unauthorised materials are handed into the Exams Officer and Invigilators, before the start of the examination. These are removed from the exam room, retained in a safe location and returned once the candidates have left the exam room.

Candidates are prompted to remove wrist watches and place them on their desks, before the start of all examinations.

## **Internal assessment**

# Leadership & Management Team

- Ensures teaching staff keep candidates' work, whether part of the moderation sample or not, secure and for the required period stated by JCQ and Awarding Body's
- Ensures work is returned to candidates after the retention period or disposed of according to the requirements

# Managing results day(s)

## Leadership & Management Team

- Identify centre staff who will be involved in the main summer results day(s) and their role
- Ensures senior members of staff are accessible to candidates immediately after the
  publication of results so that results may be discussed and decisions made on the submission
  of any requests for post-results services and ensures candidates are informed of the periods
  during which centre staff will be available so that they may plan accordingly

#### **Exams Officer**

 Works with senior leaders to ensure procedures for managing the main summer results day(s) (a results day programme) are in place

## Results day programme

Results are issued from 9am-11.30am on results day, for collection in person. Signed, written permission must be provided for a third party to collect results

#### Site staff

 Ensure the centre is open and accessible to centre staff and candidates, as required for the collection of results

## **Accessing results**

#### **Head of Centre**

- Ensures results are kept entirely confidential and restricted to key members of staff until the official dates and times of release of results to candidates
- Understands that it is not permitted to withhold provisional results from candidates under any circumstances

#### **Exams Officer**

- Informs candidates in advance of when and how results will be released to them for each exam series
- Accesses results from Awarding Body's under restricted release of results, where this is provided by the Awarding Body
- Resolves any missing or incomplete results with Awarding Body's
- Issues statements of results to candidates on issue of results date
- Provides summaries of results for relevant centre staff on issue of results date

## Post-results services

## **Head of Centre**

- Ensures an internal appeals procedure is available where candidates disagree with any centre decision not to support a clerical re-check, a review of marking, a review of moderation or an appeal
- Ensures that senior members of centre staff are available immediately after the publication of results
- Understands that if the centre has concerns about one of its component/subject cohorts, then
  requests for reviews of marking should be submitted for all candidates believed to be
  affected (candidate consent is required as marks and subject grades may be lowered,
  confirmed or raised)

#### **Exams Officer**

- Provides information to candidates and staff on the services provided by Awarding Body's
  and the fees charged (see also above Briefing candidates and Access to Scripts, Reviews
  of Results and Appeals Procedures)
- Publishes internal deadlines for requesting the services to ensure the external deadlines can be effectively met
- Provides a process to record requests for services and to collect candidate informed consent
   (after the publication of results) and fees where relevant
- Submits requests to Awarding Body's to meet the external deadline for the particular service
- Tracks requests to conclusion and informs candidates and relevant centre staff of outcomes
- Updates centre results information, where applicable

#### Teaching staff

- Meet internal deadlines to request the services and gain relevant candidate informed consent
- Identify the budget to which fees should be charged

## **Candidates**

- Meet internal deadlines to request the services
- Provide informed consent and fees, where relevant

## **Analysis of results**

# Appointed member of The Leadership & Management Team

- Provides analysis of results to appropriate centre staff
- Provides results information to external organisations where required
- Undertakes the DfE School and College Checking Exercises (where applicable to the centre) https://tableschecking.education.gov.uk

## **Certificates**

Certificates are provided to centres by Awarding Body's after results have been confirmed.

### **Certificate Issue Procedure**

Certificates will be issued at the annual Certificate and Prize Giving evening in the November following the issue of results.

#### **Candidates**

 May arrange for certificates to be collected on their behalf by providing the Exams Officer with written or email permission/authorisation; authorised persons must provide ID evidence on collection of certificates

## **Certificate Retention Policy**

Certificates will be retained for a minimum of 12 months, after which the Centre may choose to destroy any that have remained unclaimed.

# Exams review: roles and responsibilities

#### **Exams Officer**

- Provides The Leadership & Management Team with an overview of the exam year, highlighting what went well and what could be developed/improved in terms of exams management and administrative processes within the stages of the exam cycle
- Collects and evaluates feedback from staff, candidates and invigilators to inform an exams review

### Leadership & Management Team

• Work with the Exams Officer to produce a plan to action any required improvements identified in the review

## Retention of records: roles and responsibilities

#### **Exams Officer**

- Keeps records as required by JCQ and Awarding Body's for the required period
- Keeps records as required by the Centre's records management policy
- Provides an exams archiving policy that identifies information held, retention period and method of disposal
